## Board Notes

### Highlights from the December, 2014 Board Meeting

At the December Board meeting, OSMA held a hearing regarding Sanabil Halal Meat Farms. Sanabil was charged with not collecting, nor remitting licence fees to OSMA. As a result of the hearing, Sanabil was found guilty and has been ordered to pay the outstanding licence fees. Failure to meet the terms set out by the Hearing for payment will result in the suspension of its OSMA Sheep Slaughter Licence.

Time was spent discussing potential projects for this coming year. Such projects included: Developing Database Capacity for the Collection of Data Leading to Identification of Animals Genetically Resistant to Parasites; an Ovine Improvement Feasibility Project; Risk Assessment and Benchmarking Study and; a Scrapie Genotyping project. At this time, the Board supported the Database Capacity project and has asked staff to further investigate the feasibility of a Risk Assessment and Benchmarking Study and a Scrapie Genotyping project.

OSMA continues to be actively involved with GenOvis and needs to be able to solicit input from producers participating in the program when needed. Staff has been instructed to contact GenOvis producers for feedback instead of using the Breeding Stock Committee for this purpose.

The Board discussed Farm Action Now (FAN), a group that has been formed in response to the provincial government's announcement to reduce neonicotinoid seed treatment in soybeans and corn. At this time OSMA has not agreed to become members of FAN.

An update was provided on the CSF and its AGM which was held in November in Calgary. A review of how traceability is currently working in the sheep industry was given along with discussion around the database and the CSF applying to be administrator for the Canadian Sheep Identification Program.

The OSMA Board had time to review its own AGM. From the feedback provided by attendees and the Board's own experiences, they thought it went well. There was concern expressed about it being held during hunting season.

Unfortunately the Board was not able to review the resolutions that were brought to the OSMA AGM at this Board meeting. They have been tabled to the January 14<sup>th</sup> meeting.

## Ontario Sheep Donation Aids Food Bank

**December 10, 2014** (Brantford, Ontario) – The Ontario Sheep Marketing Agency (OSMA) continues its commitment to helping Ontario's hungry have access to fresh protein. In November, OSMA had purchased the Reserved Champion at the Royal Winter Fair and this morning, donated the lamb to the Brantford Food Bank.

“This is the time of year when many of us are thinking about the Christmas season and the meals we'll be enjoying with family and friends. Unfortunately, this is not the case for far too many Ontario

residents,” said Dennis Fischer, Chairman of OSMA. “The OSMA Board is encouraging lamb producers across the province to take advantage of the tax credit for farmers and food banks and donate fresh lamb to their local food banks.”

The tax credit is the first and only one of its kind in Canada, and makes Ontario farmers eligible to claim a 25% tax credit for all agricultural product that they donate to the province’s community food banks. “On behalf of the Ontario Association of Food Banks we would truly like to thank the Ontario Sheep Marketing Agency for their very generous donation,” says Carolyn Stewart, Acting Director of the OAFB. “Protein items and fresh foods are the most needed items by Ontario’s food banks, so there is no question that this kind contribution will make a great impact in the lives of those in need.”

Year after year, more than half of the food banks in Ontario continue to report that high quality protein is the most lacking and most needed item within food banks. The Ontario Association of Food Banks is working hard to address this need through increased partnerships with Ontario’s farmers. Through the provincial food bank network over 375,000 adults and children living with chronic hunger are provided with fresh, healthy food every month.

### About the OAFB

The Ontario Association of Food Banks is a network of 125 food banks and over 1,100 hunger-relief programs across the province. Together, we served 375,000 individuals, including 160,000 children, every single month. For every \$1 donated the OAFB is able to provide \$8 worth of food, or the equivalent of three meals, to families in need. Module Seven topics will focus on the principles of controlling disease outbreaks in sheep flocks. Topics covered will include Disease Control Programs, Disease Detection and Testing, Clostridial Diseases and Vaccinations, Managing the Top Five Production Related Diseases, On-Farm Biosecurity Information Guide and Creating Standard Operating Procedures for Your Farm.

Module Eight topics will focus on efficient management of the lambing season. Topics covered will include diagnosis of lamb mortality, dystocia, causes of newborn starvation, abortion diseases, ewe management preconception, pregnancy detection and artificial rearing of lambs.

All 12 modules have been generously supported by Canadian Cooperative Woolgrowers and Shepherd's Choice Breeding Stock. Individual modules have been supported by Brodie Ag and Industrial, Merial Canada and Grober Nutrition.

The registration cost for individual modules is \$250 per person for two days of instruction. A late registration fee of \$350 applies after the registration deadlines. ## Changes to Farm Licence Plate Requirements

Starting January 1, 2015, vehicle owners wishing to purchase or attach farm plates to a new commercial vehicle over 3000 kg will need to provide documentation to demonstrate that they have a farm business.

Only those clients purchasing or attaching new farm plates to a vehicle will be required to show proof of farm business as of January 1, 2015. The new requirements will not affect any current farm plate owners who are renewing their farm plates.

### **What documentation do I have to show to prove I have a farm business?**

A Farm Business Registration (FBR) number is proof that you run a farm business and any one of the following documents will prove that you have an FBR or are exempt:

1. A farm organization membership card;
2. A Gross Farm Income Exemption Certificate;
3. A letter from the Ministry of Agriculture, Food and Rural Affairs Appeal Tribunal indicating religious exemption;
4. A letter from Agricorp with your FBR number; or

5. A letter from the Indian Agriculture Program of Ontario confirming that the producer has met the FBR eligibility requirements.

### Why is the Ministry of Transportation making these changes?

Ontario's Auditor General (OAG), in its 2012 annual report on the Drive Clean Program and the 2013 annual report on ServiceOntario, noted an increasing number of vehicles with farm plates and was concerned that no verification is required to obtain farm plates. In both audit reports, the OAG recommended the Ministry of Transportation (MTO) review the requirements for obtaining a farm plate, to ensure that no abuse of the system was taking place.

As a result, MTO is implementing new requirements for issuing or attaching farm plates to a commercial vehicle. This will ensure that only qualified farmers obtain farm plates and receive the benefits associated with having a farm plate.

## OMAFRA's Sheep Management Journal

The Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) has a new sheep management journal. Designed after the popular lambing diary, it is pocket sized and spiral bound. The book is designed to collect information generated on the farm throughout the sheep management cycle. Producers can collect information about things like: on sheep and feed inventories, ram in and out dates, total numbers of lambs weaned and marketed, numbers of animals and days on pasture and health treatments. The book is divided into four main sections: animal management, health management, stored feed management and pasture management. This book provides a low tech method of recording much of the basic information needed to do a basic evaluation of sheep farm productivity on a year to year basis.

## Activity Management Calendar

A simple activity management calendar has been set up in excel that can be used to plan breeding and lambing dates for your operation. There are three templates for the activity calendar: annual, accelerated 3×2 and accelerated 5×3. These templates have been set up using common timeframes and activities for each production system. The templates are a starting point which you can use to customize a calendar for your specific operation. Activities can be added and the existing timeframes can be changed. The templates have been set up from two points of view. One centers the dates of all activities around the date the ram is put in with the ewes and the other centers the dates of activities around the start of lambing date. Once the ram in date for the start of lambing date is entered for the group, the rest of the dates are calculated automatically.
