April board meeting notes

The April OSMA board meeting opened with Rob Scott updating the board on the connections he has been making within the provincial and federal government. He has been asked by the Canadian Federation of Agriculture to be their representative on the National Farm Animal Care Council (NFACC). NFACC is an organization that brings together animal welfare groups, enforcement, government, and farmers under a collective decision-making model for advancing farm animal welfare (www.nfacc.ca). Of additional note is the ongoing communication that is occurring between the OSMA chair and the president of the American Sheep Industry.

The National Sheep Network has been working with Agriculture and Agri-Food Canada to arrange for a national meeting to bring producers from across Canada together to discuss what they need and what the industry can afford when it comes to a national voice. It is hoped that further details of the meeting (date, location etc) will be released shortly.

Farm & Food Care's Breakfast on the Farm is on a dairy goat farm in Shedden Ontario on June 24. OSMA board members will be there to help with the OSMA booth.

The board has instructed staff to start work on a sheep lobby day at Queen's Park. With the legislature rising on June 2, the fall was set as the target time to have one.

The Finance Committee presented to the board their review of board compensation rates, and AGM and education day registration rates for other Ontario agricultural organizations. OSMA rates are well within the range of other organizations and deemed to be reasonable.

The Programs Committee reported back on their first meeting which focused on the potential to integrate the Canadian Verified Sheep Program with the Ontario Sheep Health Program. While this may be a long-term goal, it is currently not recommended. There was also some discussion on GenOvis, more specifically, the measurements for loin eye depth and how programs could better align with the needs of the commercial industry.

Lake Erie Domestic Action Plan

Chris Attema, OSMA's Water Quality Specialist, presented the proposed Lake Erie Domestic Action Plan that was released by the Ontario government on March 10, 2017. Comments are due on May 15, 2017. Some of the comments that OSMA will be providing include:

No mention of policies or programs that could benefit and encourage forage based livestock agriculture in the policy or program sections;

There are livestock favourable trends in the data provided for example, livestock watersheds account for 3 of the 6 subwatersheds classified as less than 30 ug/L P;

No mention that based on the published data the average load/acre is lower from Canadian tributaries;

Ontario monitoring strategy appears to be a continuation of the current monitoring programs and data analysis;

The consideration of further regulatory restrictions on the land application of manure on frozen and snow covered ground is out of proportion with the facts and scientific reality.

OAFB Opportunity

The Ontario Association of Food Banks is launching an Every Plate Full – Canada's Largest Food Drive campaign to run from May 23 – June 9, 2017. The purpose of the campaign is to raise "meals" through peer-to-peer fundraising. For every dollar donated, 3 meals are raised. The board agreed to have OSMA participate in this.

Canada-Ontario Draft Lake Erie Action Plan to Reduce Phosphorus and Algae

Lake Erie is exhibiting symptoms of extreme stress resulting in harmful and nuisance algal blooms and zones of low oxygen that threaten drinking water quality, fish populations, beach quality, coastal recreation, the overall ecological health of the lake, and the Canadian economy. The cause of these algal blooms has been linked to excess phosphorus entering the lake. A tremendous amount of work has already been completed to reduce phosphorus loads, however much more needs to be done.

The Government of Canada and the Province of Ontario have developed a draft action plan that identifies actions to reduce phosphorus and algal growth in Lake Erie. To tackle these issues, actions from all levels of government, First Nations and Métis communities, as well as sector groups, conservation authorities, and the public is needed.

Public meetings will be held on:

- May 16, 2017 from 7:00 pm to 9:00 pm at the Dunnville Community Lifespan Center, 275 Ramsey Drive, Dunnville, ON
- May 18, 2017 from 7:00 pm to 9:00 pm at the Chatham-Kent John D. Bradley Convention Centre, Meeting Room 1A, 565 Richmond St., Chatham, ON

For both meetings, free parking is available on site. The doors will open at 6:30 pm. There will be a formal presentation between 7:00 pm and 7:30 pm which will provide an overview of the issues and highlight actions proposed in the draft plan.

Following the presentation, there will be opportunity for the public to ask questions about the draft action plan and provide comments and feedback on actions that can be taken to reduce phosphorus. Coffee and light refreshments will be provided.

Price predictability tool available for sheep farmers

OSMA has developed an online tool to help predict lamb prices in two weight categories – 65 to 79 pounds and 95 to 109 pounds. The tool was developed in partnership with the University of Guelph and OMAFRA.

The tool uses current and historical market data and statistical modelling to predict the price of lamb from one to four weeks out. The model is updated weekly, as market information is made available.

Small ruminant adult mortality project launched

The Animal Health Laboratory (AHL), the Ontario Veterinary College (OVC), and OMAFRA are conducting a study investigating small ruminant moralities on-farm.

Adult sheep and goat mortalities are rarely sent to a laboratory for a complete post-mortem and veterinarians infrequently perform post-mortems on-farm. However, there is value in knowing why an animal died (chronic wasting diseases, metabolic/nutritional diseases, neurological disorders, parasite problems), so that changes can be implemented to help prevent on-going disease.

This project seeks to improve the practice of on-farm post-mortems, and improve information flow among producers, veterinarians, and pathologists. The cost of laboratory testing and the post-mortem fee will be covered by the project. In order to learn the most from this project, the project will be requiring a Premises Identification (PID) number on all submissions.

Only veterinarians licensed to practice in Ontario and who provide veterinary services to Ontario sheep and goat farms are eligible to enroll in the project. The farming operation **must** be raising animals for meat, milk or fibre, i.e. pets and hobby farms are not eligible. **Please contact your veterinarian for more details and to ensure that they have requested a project account**.

Last intake for *Growing Forward 2* cost share funding assistance begins May 12

The last intake for applications for *Growing Forward 2* cost share funding assistance will be from May 12 to June 1, 2017.

Changes to the program were recently announced and a summary can be found here: http://www.ontariosoilcrop.org/oscia-programs/growing-forward-2/.

Highlights of the changes include:

- There is no limit to the number of active applications a farm business may have open at any given time.
- Producers may submit up to two applications per application intake to any of the project categories.

*GF*2 funding can also be used for education and professional development purposes. If you are planning on attending an education event or conference in 2017, you should apply for *GF*2 funding now. The Sheep Shearing School for Beginners (in late September) and the Advancing Women in Agriculture Conference both qualify for producers to receive some reimbursement for costs under the program.
