### New partnership announced to secure natural gas access in rural Ontario

On October 4, OFA along with the Eastern and Western Ontario Wardens' Caucuses announced their intention to get a commitment from the Ontario government to provide access to natural gas for rural Ontario over the next 20 years. The proposal seeks a significant public investment with the appropriate accompanying policies from the Ontario Energy Board.

Such a commitment would provide significant advantages for farming and rural Ontario in terms of ongoing energy costs – up to \$1 billion per year.

### Updated selection indexes for GenOvis coming this November

The needs of the sheep industry have evolved in recent years, so genetic selection guidelines had to be reviewed. Therefore, in November of this year, the genetic evaluation program, GenOvis, will update its selection indexes. The planned adjustments will serve to broaden genetic advancement and will specifically target breeding characteristics that carry an economic impact. These new indexes will also meet the needs recently expressed by purebred and commercial producers. ### Update on Ontario sheep industry growth strategy

OSMA has embarked on an aggressive competitiveness project for Ontario's sheep industry. The purpose of this initiative is to identify the knowledge, capabilities and relationships required for our industry to achieve its targeted level of growth by establishing a means of benchmarking industry performance. The project is funded by the Ontario Ministry of Agriculture Food and Rural Affairs.

Benchmarking in agriculture is, as extension agents say, a practice that is not well understood and is considered a complex and costly process, suited to only large businesses. However it does not need to be complex or expensive, and provides value to farms of any size. For producers, benchmarking enables them to make informed management decisions. For advocacy groups and governments, benchmarking enables them to tailor policies and programs to industry's immediate, medium and longer-term needs. The further that the benchmarking process extends along the value chain, the greater its value to farms, other businesses and industry.<sup>1</sup>

Franks and Collis (2003:2)<sup>2</sup> describe benchmarking as comparing the performance of your farm against other farms engaged in similar activities, and "learning from the lessons that these comparisons throw up." For producers, the purpose of on-farm benchmarking is to enable you to identify how to improve your profitability by comparing your financial and operational performance against your peers and the wider industry. Benchmarking provides a guide on 1) where best to invest in your business, 2) how to measure your rate of improvement, and 3) how to increase customer satisfaction and market size.

When differences in performance are identified, the information that you gain from the benchmarking helps you identify exactly why and how your peers' performance was achieved. This learning enables you to implement changes more effectively, efficiently and faster than otherwise possible, and know that the changes you are making will almost undoubtedly produce measurable benefits. This may result in you improving your own farm's performance beyond what your peers are achieving: perhaps by producing lambs that meet market demands better than lambs sourced from elsewhere. Benchmarking also enables producers to reduce costs while, potentially, simultaneously increasing revenues.

To reduce the complexity and increase the value of benchmarking, Franks and Collis (2003) suggest that producers follow a ten step process:

- 1. Identify key performance indicators (KPIs) for whole of farm and individual enterprises;
- 2. Select data suited to measuring your chosen KPIs;
- 3. Choose the methodology for determining financial and physical performance measures;
- 4. Collect and enter the chosen data;
- 5. Conduct a comparative analysis to identify high, low and average (or median) performance;
- 6. Investigate reasons that determined high, low, and average performances at a generic industry level; then identify how the highest performance was achieved;
- 7. Repeat step 6, though at an individual farm level to identify key constraints that may impact the performance of yours or the benchmarked farms' KPIs, and how you act upon the information;
- 8. Compare the resources (time, money, etc.) required to replicate key opportunities on your farm;
- 9. Produce an "improvement action plan" for your overall farm and/or individual enterprises; and
- 10. Implement your "improvement action plan" systematically in your farming operations.



### Minimum Distance Separation (MDS) information sessions

OMAFRA is hosting as series of webinars and information sessions about the revised Minimum Distance Separation (MDS) document and accompanying AgriSuite software. It's a land use planning tool developed by OMAFRA with the objective of minimizing potential nuisance odour complaints associated with livestock facilities and anaerobic digesters. The tool generates reciprocal setbacks between livestock facilities and sensitive land uses with the long-term goal of reducing land use conflicts.
